#### **DESCRIPTION**

An analytical study of the Book of Acts that examines the foundation and early development of Christianity. Particular attention is given to the transition from Israel to the Church and Paul's missionary journeys.

This course is offered in two formats: in-person and online. Students registered for in-person attend the classes in person, online students attend the classes via the online classroom. For both in-person and online students, assignments, and interaction outside of the class period are done in the learning management system.

# **OBJECTIVES**

### **Assignments**

# 1. Reading

- a. Read Acts: Read through the book of Acts <u>eight times</u> (once for every two weeks of class. This reading is to be reported in Canvas. Audio listening is also acceptable as well as a mixture of methods. More information on this assignment is in Canvas.
- b. Read through the portion of the textbook according to the tentative schedule. This reading is to be reported in Canvas. More information on this assignment is in Canvas.

## 2. Study Questions

Each week student's will answer a set of study questions in preparation for class. The study questions are found in Canvas. More information is in Canvas along with due dates.

# 3. Personal Application Paper

As you are reading through the Book of Acts, write a personal application for each chapter of the book. Each of these applications should be at least a half page in length and be directly tied to the text, including references. The completed assignment will be due at the end of the course and should be a minimum of 14, 15 pages long. See Canvas for more details.

#### 4. Outline

Utilizing Acts 1:8, create your own outline of the book. See Canvas for more details.

#### 5. Lesson Plan

Create a lesson plan for teaching a topic from the book of Acts.

Examples include...

- a. Speaking in Tongues in Acts
- b. Missions in Acts
- c. The Creation of the Church
- d. Another topic of interest to the student

The topic should be approved by the professor prior to beginning the assignment. See Canvas for more details.

# 6. Research Paper

The student will use their lesson plan as an outline for a 10-page research paper. The research paper takes the place of a Final Exam and should be turned in by the end of the course. Papers should be in Turabian Research Paper format, including Title Page and Bibliography. The student is encouraged to utilize a minimum of 15-20 sources for this paper.

#### **METHODS**

- **A. In-class methods:** listening to lectures, participating in group discussions.
- **B. Out-of-class methods:** reading, writing, research, participating in Canvas, and studying for tests.

Unless otherwise indicated book reports and study questions may be in non-research format, interviews and other research papers should be in research paper format. - **E. Late Assignments**: Assignments will be penalized according to the professor's late policy as explained in Canvas.
- **F. Plagiarism**: Plagiarism is defined as copying any content without identifying the source. This also includes taking another person's or AI entity's ideas or constructs and presenting them as your own. Plagiarism of any kind will not be tolerated. Most assignments at Calvary require the student to produce original work. Therefore, unless specifically permitted by the instructor, the use of AI-generated content is prohibited (even if cited) as it does not represent original work created by the student and is an unreliable aggregate of ideas from other sources. AI, however, may be utilized in cases where the instructor has explicitly permitted its use to accomplish specific tasks. It is only in these cases that AI-generated (or modified) content may be submitted by the student. If there are any questions as to the permissibility of AI use for an assignment, please ask your instructor for clarification.

Any assignment that includes plagiarism will receive a zero (0) grade. Students should note that papers will be submitted in Canvas via "Turn-It-In". This program automatically gives the student's work a plagiarism score, students should strive for a score less than 20.
