DESCRIPTION

The Ph.D. candidate will write the first 75 pages of the dissertation.

The Ph.D. candidate must pay the fee for the dissertation advisor and reader each eight weeks (see catalog for amount of the fee).

COURSE OBJECTIVES

The student will:

- 1. Research the topic of his/her dissertation by reading books, journal articles and dissertations (PLO 5) (A1-4)**
- 2. Write the first 75 pages of his/her dissertation (PLO 5) (A1-4)**
- 3. Meet with his/her dissertation advisor and reader to discuss his/her dissertation (PLO 5) (A1-4)**
- 4. Make changes/revisions to his/her dissertation when advised (PLO 5) (A1-4)**

REQUIRED TEXTBOOK

The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (meaning that the translation is generally word-for-word from the original languages), including any of the following: New American Standard (NASB), English Standard Version (ESV), New King James Version (NKJV), or King James Version (KJV). Other translations like NLT and NIV may be used as supplemental sources. Please ask the professor if you have any questions about a particular translation or version.

REQUIRED: ORIGINAL LANGUAGE BIBLE STUDY SOFTWARE (Accordance, Bible Works, Logos)

Students are required to have digital resources to engage Biblical study in the original languages, including but not limited to *Biblia Hebraica Stuttgartensia (BHS)*, *Nestle Aland 28 (NA28)* – both including critical apparatus; *Septuaginta (LXX)*, *a Greek Lexicon of the New Testament and Other Early Christian Literature (BDAG)* by Bauer, Danker, Arndt, and Gingrich; *Hebrew and Aramaic Lexicon of the Old Testament (HALOT)* by Koehler and Baumgartner.

ASSIGNMENTS

Assignment #1: Write a detailed outline/argument of the first 75 pages of your dissertation (200 points)

Assignment #2: Meet with your dissertation advisor and reader in Microsoft Teams to discuss the outline/argument of your first 75 pages of your dissertation (100 points)

Assignment #3: Write pages 1-75 of your dissertation (600 points)

Assignment #4: Meet with the dissertation advisor and reader in Microsoft Teams to approve pages 1-75 of the dissertation (100 points)
