#### I. DESCRIPTION

A course designed to study the symptoms and underlying personal and interpersonal dynamics of the major categories of dysfunction as found in the DSM manual. Special attention is given to providing an understanding of these disorders according to a Christian worldview. (Prerequisite: CO601, CO603, CO610, and CO611)

This course uses a blended model of delivery, meaning that both campus and online students take this class together. Campus students attend the classes in person, online students attend the classes via the online classroom. All interaction and assignments for campus and online students are done in Canvas. Students wishing to pursue state licensing in the State of Missouri must take the class in person.

### II. OBJECTIVES

## A. General competencies to be achieved.

- 1. The student will develop a broad understanding of psychopathology. (PLO 2, 3, 5)
- 2. The student will develop a deeper understanding of the origins and treatment of psychopathology in light of a Christian Worldview and Scripture. (PLO 1, 2, 3, 5)
- 3. The student will be exposed to different modalities and treatment options. (PLO 2, 3, 5)
- 4. The student will be able to dialogue with other professionals and third-party payers. (PLO 2, 3, 5)

## B. Specific competencies to be achieved.

- 1. The student will develop a deeper understanding of how to practice self-care for personal wellness. (PLO 1, 4)
- 2. The student will become proficient with the diagnostic system of the DSM-5. (PLO, 2, 3, 5)

# III. REQUIRED TEXTS/MATERIALS

## IV. REQUIREMENTS

# A. Class Participation (10%)

Students are expected to engage in discussion or presented topics. Personal involvement during class time is an essential element of active learning and students will be graded accordingly. (GC 1, 2, 3, 4, 5; SC 1, 2)

### B. Reading Assignments (10%)

- 1. *Diagnosis Made Easier, Second Edition* is due by May 17th. Students will report completion of reading in writing on Canvass. Due ##### (GC 1, 3, 4; SC 2)
- 2. Modern Psychopathologies: A Comprehensive Christian Appraisal is due by June 2nd. Students will report completion of reading in writing on Canvass. Due ##### (GC 1, 2, 3, 4; SC 2, 3)

## C. Written Assignments (50%)

Plagiarism is defined as copying any content without identifying the source. This also includes taking another person's or AI entity's ideas or constructs and presenting them as your own. Plagiarism of any kind will not be tolerated. Most assignments at Calvary require the student to produce original work. Therefore, unless specifically permitted by the instructor, the use of AI-generated content is prohibited (even if cited) as it does not represent original work created by the student and is an unreliable aggregate of ideas from other sources. AI, however, may be utilized in cases where the instructor has explicitly permitted its use to accomplish specific tasks. It is only in these cases that AI-generated (or modified) content may be submitted by the student. If there are any questions as to the permissibility of AI use for an assignment, please ask your instructor for clarification. (Note: Turn-It-In.com will be used to verify assignment integrity.)

All papers must follow APA style according to the revised 7<sup>th</sup> addition unless otherwise stated in the syllabus. For questions please consult the Publication Manual of the American Psychological Association, (6<sup>th</sup> ed., 2<sup>nd</sup> printing) or http://owl.purdue.edu.

- 1. Write a 6-page summary (three pages per chapter) on chapters 1 and 2 (Classification in Historic Pastoral Care and Classification in Contemporary Mental Health) from *Modern Psychopathologies* (10%). Due ##### (GC 1, 2, 3, 4; SC 2)
- 2. A case study will be provided in class. The student must write a 4-page paper that determines the key issues presented, provides diagnostic impressions based upon the DSM-5, and includes treatment recommendations that support a collaborative effort and include a bio/psycho/social/spiritual approach. The case study must include at least 4 scholarly sources in addition to referencing the course textbooks and the Bible. **Due** ##### (10%). (GC 1, 2, 3, 4; SC 2)
- 3. Write a 10-page research paper according to the guidelines below. **Due** ##### (20%) (GC 1, 2, 3, 4; SC 2)
  - a. Select a diagnosis from the DSM-5 (ask professor for approval before you start working on your paper).
  - b. Use at least 6 scholarly, preferably peer reviewed, sources (books and/or journal articles) besides the textbooks and the Bible.
  - c. Include the following areas:

- i. A succinct overview of the chosen disorder in the DSM-5 category (do not copy and paste from the DSM-5 this information must be evaluated and reworded into your own words):
- ii. Potential causes of the disorder (genetics, heredity, social, cultural environment, behavior, etc.).
- iii. Discuss how this disorder is viewed through a Christian worldview.
- iv. Possible treatment interventions to help someone struggling with this disorder.
- 4. Write a 5-page reflection paper answering the following questions. **Due** #####(10%). (GC, 1, 2, 3, 4; SC 1, 2). This paper does not require APA format.
  - a. In what ways have you been personally impacted by one or more diagnosis from the DSM-5?
  - b. In what ways has your family been impacted by one or more diagnosis from the DSM-5?
  - c. How is mental illness a family problem?
  - d. How have you experienced the church being either helpful or unhelpful when you have struggled? (Do not overthink defining the church.)
  - e. Do any of the treatment options discussed in this class help you maintain personal wellness?

## D. Interview (30%)

The student will conduct an interview with a Christian LPC (Licensed Professional Counselor) and write a summary of the interview: (GC 1, 2, 3, 4; SC 1, 2) **Due** #####

The student will ask the following questions:

- 1. How does a Christian worldview affect your treatment of mental illness?
- 2. In your opinion, how are sin and psychopathology related?
- 3. Have you found any diagnosis in the DSM-5 challenging to interact with? If so explain.
- 4. How have you seen the church interact with issues of mental health (both in a positive and unhelpful way)?

The summary will include: (1) a short biography on the professional, (2) a history of his or her specific professional context (probably place of employment), (3) The three questions and responses. These summaries do not require APA format.
