This course is offered in two formats: in-person and online. Students registered for inperson attend the classes in person, online students attend the classes via the online classroom. For both in-person and online students, assignments and interaction outside of the class period are done in the learning management system.

I. DESCRIPTION

This course provides an extensive overview of legal principles and ethical issues in sport. This course introduces the different fields of law and issues (Federal Amendment, torts, contracts, labor relations) as they relate to sport. Furthermore, this course is designed to help future sport administrators develop an ethical decision-making process based on biblical principles.

II. OBJECTIVES

- 5. Identify the framework for risk management in a coaches setting and develop

a philosophy that creates safety instead of harm for participants. (Program Learning Objectives: 3 and 4) (Assignments: 2, 3,4, 7, 8)

- Know the steps in a lawsuit and the responsibilities and obligations of the parties: plaintiffs, defendants, judges, and others. (PLO: 1,2,4,5) (Assignments B,C,D)
- Analyze, distinguish, and apply the legal and ethical concepts of sport to respond to challenges commonly encountered in the arenas of sport and physical activity. (PLO: 4,5)

- Demonstrate an understanding of the interdisciplinary nature of the study of ethics and sport and the biblical model. (PLO: 1,2,3)

III. MATERIALS

A. BIBLE - The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (meaning that the translation is generally word-for-word from the original languages), including any of the following: New American Standard (NASB, English Standard Version (ESV), New King James (NKJV), or King James (KJV). Other translations and versions based on dynamic equivalence (paraphrases, and thought-for-thought translations like NLT and NIV) may be used as supplemental sources. Please ask the professor if you have questions about a particular translation or version.

A. Discussion Questions

The student will answer discussion every other week depending on the topic. They will comment on two other classmates' views concerning the questions.

Assessment and Debates

Daily assessments will be given in class. Each student will complete each debate and assessment.

Reading and Response

The student will read the assigned chapters for Introduction to Sport Law. They will answer the discussion questions for the assigned chapters.

The student will read assigned case studies in the book, Case Studies in Sport Law. They will write a review of each case study assigned (8 case studies) in the book.

The student will read the book Ethics in Sport and answer the discussion questions assigned for each chapter.

B. Writing

- 1. The student will find and define ethical and legal terms.
- 2. The students will be debating in class concerning ethicial issues in sport. This section will primarily target the current issues of today using good research and bible based foundations.
- 3. All class papers must follow the APA style according to the Publication Manual of the American Psychological Association, 7th edition.
